## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Coedkernew Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of Qualification

#### Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1 and 3: The Council did not approve the accounts by 30 June 2024 as required by the Accounts and Audit (Wales) Regulations 2014  
I have not seen evidence that the Council published the required notice to explain the late approval.
- Assertion 2: The Council did not maintain an adequate system of internal control during the year and the response is inconsistent with the conclusions reported by the Internal Auditor.
- Assertion 3: Compliance with relevant laws and regulations. The Council has not published information it is required to publish electronically by the Democracy and Boundary Commission Cymru etc. Act 2013.
- Assertion 3: The Council has not provided evidence that a budget has been set in accordance with the Local Government Finance Act 1992 and that the precept has been set in line with the budget. The Act requires the Council to take into account its estimated income when setting its budget requirement. We recommend that the Council sets a budget in accordance with the relevant regulations and codes of practice.
- Assertion 4: The late approval meant that the Council did not make proper arrangements for public inspection of accounts

## **Arrangements to secure economy, efficiency and effectiveness in use of resources**

In my opinion, the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources:

- I have not been provided with a copy of the Council's Financial Regulations in order to confirm proper arrangements are in place for procurement.

## **Other matters and recommendations**

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

### **Clerk's salary**

As part of our routine audit work, we check payments of the clerk's salary back to their contract of employment to confirm the gross salary paid. Our audit identified that the Council appears to have underpaid the Clerk and has not paid them in accordance with their contract i.e monthly.

We recommend that the Council reviews payments of the clerk's salary to confirm the correct amount has been paid.
